Bridport Camera Club Privacy Policy

The only personal data the Club holds are the:

- Names, address, telephone number and email addresses provided by members on their application forms.
- Accounting information about member's subscription payment and to which competition section they have been assigned.
- Names and email addresses of former members and any other individuals who have opted to receive club communications.
- Names and contact details of judges and speakers.

This information is held for membership purposes, emailing communications about club activities and general club administrative activities. The data is held manually and on password protected computer filing systems and is maintained by the club's elected officers for their sole use. We will never share your details, nor will we use your data for any other purpose than that stated above.

We update the data when requested and annually when subscriptions are renewed. We retain names and email addresses of former members. If, at any time, you wish any or all of your details to be removed from our records please let us know and you will receive no further communications from the club. Instructions for how to do this are included on all club emails.

Personal data held by an external service:

The Club uses an external service, PhotoEntry.uk, to help manage competitions. Member's name, e-mail address and competition section will be provided to PhotoEntry.uk in order for members to submit their competition images. PhotoEntry will store images and competition results and make them available only for Club purposes. The PhotoEntry.uk system may send e-mails relating to the service they provide to members, such as details of competitions and things like requesting password changes, and the competition secretary can send messages this way too.
